Town Board Meeting Minutes

Town Board Meeting of the
Town of Plum Lake held at the Town Hall in Sayner on
Wednesday, December 4, 2024, at 5:30 PM

1. Open Meeting Verification:

The meeting was duly called by Chair Postuchow with the notice posted at the Town Hall in Sayner, the US Sayner Post Office, and notice was given to the *Vilas County News-Review*, *The Lakeland Times*, WRJO, WERL, as well as posted on the Town of Plum Lake website.

2. Roll Call:

3. Pledge of Allegiance

4. Approve Agenda to Be Discussed in Any Order:

Supervisor Rasmussen made a motion to discuss the agenda in any order. Seconded by Supervisor Eliason. **Motion Passed Unanimously. (3-0)**

Supervisor Rasmussen moved to accept the minutes from the November 13, 2024, Town Board Meeting as submitted. Second by Supervisor Eliason. **Motion Passed Unanimously. (3-0)**

6. Discussion and Possible Action on the following:

A. Sayner-Star Lake Chamber-Budget Report: Chamber President Helen Bryner reviewed the Budget Summary for the Chamber. She noted that Cloverland will be added to the Chamber with rebranding taking place with this change. Bryner also shared that Sayner/Star Lake along with three other Northwoods communities will be featured on an upcoming episode of *Discover Wisconsin*. Filming will take place in January 2025 and the segment will air in February 2025.

Community member, Lauri Gerlach shared a proposal for a multi-use schedule and signage suggestions for the Tennis/Pickle Ball Courts. After discussion, Supervisor Rasmussen moved to accept the schedule proposal and order signage for the courts after signage wording is solidified by the board. Supervisor Eliason seconded the motion. **Motion Passed Unanimously. (3-0)** Funds taken from 55202 Parks and Grounds Maintenance for signage to be placed at each entrance of the court and any additional signage deemed necessary to adequately mark the court area.
